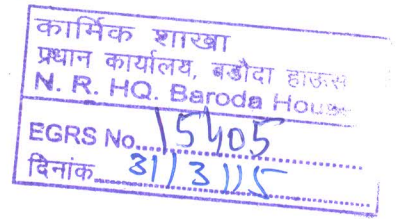

A proposal for providing incentives to the staff/officers posted on the USBRL Project and identified "difficult project" of N.F. Railway (Const.) has been under consideration of the Board for sometime, and it has been decided as under:-

2. Incentive in the form of air travel facility as detailed below may be allowed to the officers posted on the USBRL Project and identified "difficult project" of N.F. Railway (Const.).

N.F. Railway (Const.)	USBRL
While on leave (all types including C.L.), free air travel with family (as per pass rules) twice a year, including one journey already available from place of posting to the nearest airport, to the employee's home town / family station and back, in lieu of one set of privilege passes each time, if posted on "Difficult Projects" of N.F. Railway.	While on leave (all types including C.L.), free air travel with family (as per pass rules) twice a year, from Jammu/Srinagar to the nearest airport to the employee's home town / family station and back, in lieu of one set of privilege passes each time.

3. The above incentives will be limited to the project construction phase and will be applicable to all the officers related with these projects except those who are posted at Maligaon/Guwahati.

4. This issues with the concurrence of the Finance Dte. of Ministry of Railways.
